1. I say that I have been functioning as Secretary, Atomic Energy Education Society w. e. f. 19.12.2012.
2. I say that the said Society is an autonomous body of the Department of Atomic Energy, Union of India, established under the Bombay Public Trust Act, 1950 having its Registration No. F/1854 (Mumbai). The said Certification No. 02920 is issued on 31.12.1969 by the Assistant Charity Commissioner, Greater Bombay Region, Bombay.
3. I further state that the said Society is also registered under the Societies Registration Act, 1860 and The Assistant Registrar of Society, Greater Region; Bombay has issued a Certificate with Maharashtra State Registration No. Bom.23/69 G.B.B.S.D. to that effect to the said Society.
4. I further state that the Atomic Energy Education Society has made an application for grant of affiliation /up gradation to the Central Board of Secondary Education, having its office at Shiksha Kendra, 2, Community Centre, Preet Vihar, Delhi-

5. I state that the Atomic Energy Education Society is governed by Memorandum of Association and bye-laws as amended from time to time upto 19.09.2001.
6. Under the Constitution of the said Memorandum and bye-laws the affairs of the Society are managed by Governing Council consisting of a) Chairman, b) Secretary, C) Treasurer and such other members not exceeding 15 as the Chairman may decide. The Chairman is nominated by the Chairman, Atomic Energy Commission/Secretary, Department of Atomic Energy, Union of India. The Secretary is appointed by the Chairman of the Society with approval by the Chairman, Atomic Energy Education Commission/Secretary, Department of Atomic Energy, Union of India. The Treasure is nominated by Chairman of the Society from amongst the core members.
7. I say that all the expenditure of the said Society is fully funded by the Department of Atomic Energy, Union of India.
8. I say that the Trust or Society and the management running the school is of non proprietary character.
